RE: Simple legal method to block second term for Trumpolini

Dear DNC Chair Perez, and Hon. Andrew Cuomo, Governor of New York

- A) Proposed "moral character" state law for presidential electors;
- B) Supporting Constitutional law: see Chiafalo v Washington #19-465, July 6, 2020;

A: *Moral character of a President:* Whereas the person elected to the office of President of the United States exercises tremendous power over public policy and great influence over the quality of public life throughout the nation, it is advisable that the successful candidate be a person of good moral character. Therefore, it is hereby enacted and ordered that the appointed and pledged presidential electors of the honorable State of New York shall not cast their presidential elector ballot for: A) a candidate who was convicted, within the previous twenty years, of a felony offense; B) a candidate who has been impeached by the House of Representatives.

Renunciation of Elector Pledge: If the candidate of the political party to which an Elector is pledged suffers the cloud of poor moral character of either a felony offense or having been impeached, then the Elector must renounce their pledge and cast their ballot for another presidential candidate who does not carry the stain of either of these two signs of poor moral character.

Basis of this provision: The basis of this provision is in part that a President who is impeached by the House of Representatives has been found to have failed to perform his duties to assure that the laws are enforced and the public health and safety are protected.

B: Supreme Court #19-465, July 6, 2020 (9-0). In this decision the Court summarized and referenced the cumulative repetition of the same legal interpretation from several previous decisions: **The state legislatures exercise complete control over *WHO* their presidential electors *CAN* vote for and *CANNOT* vote for.**

Selected citations:

Almost immediately, presidential electors became trusty transmitters of other people's decisions.

Courts and commentators throughout the 19th century recognized the electors as merely acting on other people's preferences.

Any reasonable person, or even an unreasonable lawyer, who reads this decision will have no doubt that the court has ruled here (9-0) that ***the state legislature of each state literally instructs each of their Presidential Electors who to vote for and each Elector is legally bound to vote as instructed.***

C: The opinion polls DO NOT tell us who is going to vote or who they will vote for. Opinion polls do not reveal future votes because the participants in the poll believe that who they vote for is private and the right to a secret ballot is a sacred right. They do not want their neighbors to know who they voted for or will vote for. The voting patterns of 2016 will be repeated in 2020. It is possible that neither Biden nor Trump will receive 270 electoral votes in the first stage of the presidential election. That outcome spells cosmic disaster for the American ***political*** climate.

If the presidential election is passed to the second stage, it is possible that Donald Trump will be re-elected by the 26 least populous states, therefore he could be re-elected by less than 40% of the population. The American people would be devastated, confused, angry, more angry than ever. Most Americans believe that the President should be elected by them, and do not understand that the election rules adopted by the states cause the President to be elected by the STATES, and not by the people or the Electors. Although we already are coping with multiple disasters, this last disaster presents the prospect of civil war.

Therefore, it serves the best interests of the nation for New York and other states to pass the "moral character" law suggested above. There are 15 states with both legislative chambers and state house controlled by the Democrats, and 5 more states with the legislature controlled by Democrats with a Republican governor, and these 20 states control 230 electoral votes, just 40 votes from victory.

Weigh your choices carefully my friends, either you stop Trumpolini by all legal means, or prepare yourself for a second American Civil War. Get Germany in 1933 printed on your mind, and keep it focused. It can happen here.
